The Republic of Sierra Leone is washed by the Atlantic Ocean and shares its border with Guinea (north) and Liberia (south-east) in the African Continent.

## 4. Political Information

Sierra Leone gained Independence in 1961 and became a Republic in 1971, with an executive president. From 1967-2002 Sierra Leone went through a period of political instability and civil strife as there were numerous coups and the civil war. In May 2002, legislative and presidential elections were held with

Commonwealth observers present, which were won by the Sierra Leone People's Party (SLPP). In 2007, the All People's Party won the election and Mr. Ernest Bai Koroma was sworn in as President. Commonwealth observers reported that the election was carried out in a democratic and credible manner in accordance with internationally accepted standards.

## **CANADA/CARICOM TRADE AGREEMENT UPDATE!**

As the 2011 expiry date of The World Trade Organization (WTO) waiver under CARIBCAN approaches, Trinidad and Tobago is preparing to begin negotiations on the Canada/CARICOM Free Trade Agreement. The first round of meetings of the CARICOM Technical Working Groups will take place in Barbados at the Grand Barbados Hotel from 19<sup>th</sup> to 23<sup>rd</sup> October in Services, Investment and Market Access. The first round of negotiations between Canada and CARICOM are due to commence on 16<sup>th</sup> November 2009 in Barbados with a second round planned for early 2010.

In September 2009, The Honourable Stockwell Day, Minister of International Trade, Canada met with a select group of CARICOM Ministers led by Minister of Trade and Industry, Mariano Browne in Trinidad and Tobago. They met to discuss a number of issues including the extent of Ministerial Engagement in Negotiations and the inclusion of a Development dimension in the Trade Agreement.

Whilst in the country, a special meeting was convened with Business Sector Organizations and Minister Stockwell Day to discuss expanding trade between Canada and Trinidad and Tobago and the possible outcomes the private sector expects from such a trade agreement with Canada. The President of the Trinidad and Tobago Chamber of Industry and Commerce, Angella Persad and Manager – Business & Sector Services, Camille Sears-Carter Wells raised issues pertaining to how the Rules of Origin do act as a technical barrier to trade since the requirements from province to province differ; in addition to this issue raised by members were the labeling requirements in French and English speaking Canada and clarity on Commercial Presence i.e. setting up business in Canada with respect to the taxes and licence requirements.

In 2008, merchandise imports from CARICOM totalled \$1.6 billion and included natural resource products such as inorganic chemicals, precious stones and metals, organic chemicals, iron and steel, beverages, mineral fuels and oils, fish and seafood, and fertilizers.

Canadian merchandise exports to CARICOM totalled \$906.4 million and included mineral fuels and oils (not crude), mineral ores, cereals, machinery, paper and paperboard, fish and seafood, and electrical and electronic equipment.

In 2008, two-way merchandise trade between Canada and CARICOM countries amounted to \$2.5 billion (a 15.8-percent increase from 2007).

CAIRBCAN is limited to trade in goods and does not cover trade in services, which currently accounts for an increasing proportion of trade between Canada and CARICOM.

## **BUSINESS OPPORTUNITIES AND TRADE REQUESTS!**

**The National Infrastructure Development Company Limited (NIDCO)** is a special purpose state enterprise established by the Government of the Republic of Trinidad and Tobago (GORTT) for the execution and implementation of projects which fall within the purview of the Ministry of Works and Transport. GORTT intends to carry out major network enhancements to the highways network by constructing the National Network of Highways Project (NNHP).

The NNHP implementation plan consists of three (3) phases of work to be executed prior to 2025. Phase 1 of the NNHP consists of seven (7) packages of approximately 250 km of highway development with the procurement process commencing in November 2009. NIDCO is implementing Phase 1 of the NNHP on behalf of GORTT and is seeking Expressions of Interest from major design and construction firms, joint ventures and/or consortia interested in providing Design/Build contracting services for the implementation of Phase 1 of the NNHP or any part thereof.

An information meeting will be held for all interested parties at the Hilton Trinidad and Conference Centre on October 21, 2009 at 9a.m. Proposers planning on attending the information meeting are asked to confirm their attendance with the names of attendees as soon as possible by e-mail to [trinidadhighways@nidco.co.tt](mailto:trinidadhighways@nidco.co.tt). Proposers will be able to collect the EOI documentation at this meeting or by request to the above email. EOIs are to be submitted no later than 12:00 noon (EST), November 11, 2009 at the offices of NIDCO at First Floor 122 St. Vincent Street, Port of Spain, Trinidad [FAO: The Secretary to the Tenders Committee].

**The Art Society of Trinidad and Tobago** has collaborated quite successfully with the Label House Group in the production and installation of large scale re-productions of paintings at the Oval and at the Hyatt Waterfront. They have just launched an effort to procure new work for re-production to coincide with the opening of the Commonwealth Heads of Government Meeting in November 2009. Artists have been asked to paint to the theme "*Sustainability and the Elimination of Poverty*". It is proposed that at least one hundred (100) new works would be installed around the perimeter walls of the Oval and the walls of the British High Commission facing the Oval.

A launch would need to be planned, as well as simultaneous exhibition of the original works that are juried and selected as well as the limited productions of prints and a comprehensive brochure featuring the artists and their works.
