It also says that an organization understands that business goes beyond just a narrow focus on the bottom line. It also entails developing meaningful long-lasting relationships with all stakeholders.

In Trinidad and Tobago, Corporate Social Responsibility is a relatively new field of expertise, and therefore the role of the Chamber's CSR Committee becomes more salient in emphasizing that businesses whether small medium or large have a social, environmental and ethical responsibility which if met leads to sustainable development. Although CSR may be still in its embryonic stage, it has gained momentum particularly in the private sector. Public sector organizations of course have been heavily involved in this area in the past but now more than ever the private sector is fulfilling their role as socially responsible corporate entities which promote sustainable development – a theme which I am sure will be continuously addressed during this session and the others to come.
