Sonji Pierre-Chase is the President of The Trinidad and Tobago Chamber of Industry and Commerce. With over 25 years of experience in property law, conveyancing, and commercial transactions, she has advised major financial institutions. Her expertise extends to International Trade Law and Anti-Trust Law, having served as a Legal Trade Specialist at the Ministry of Trade & Industry. She previously held legal roles at Petrotrin and The T&T Chamber and has contributed to Intellectual Property Law reform.

Sonji is an Associate Tutor at Hugh Wooding Law School and currently leads the Conveyancing and Property Department at JCS Caribbean Law. She holds a Bachelor of Laws degree from the University of London, a Legal Education Certificate from Hugh Wooding Law School, and a Master of Laws specializing in Conveyancing & Contracts and International Trade Law. Additionally, she has postgraduate diplomas in International Relations and Anti-Trust Law. Ms. Pierre-Chase will work alongside Chief Executive Officer Vashti Guyadeen and the management team at The T&T Chamber.

At the Annual Business Meeting, Ms. Pierre-Chase reaffirmed: "When I say we don't just talk, we act, I can proudly say today that, over the last 146 years, we have assiduously advocated for our members and, by extension, all businesses.
