This Seatrax Crane and Pedestal and was moved from Louisiana, via Houston TX to Chaguaramas Terminals for the client.

PACKAGE BOILER

Cargo moved from manufacturer's shop floor to barge by truck, then to river port and moved to Houston by Barge; from Houston port to Pt. Lisas port by ocean vessel; discharged by vessel's cranes directly onto modular trailers and moved to customer's site in Point Lisas.

Cargo moved from VIT Airport, Spain to Piarco Airport, Port Of Spain. This Russian Aircraft had not previously landed in Port of Spain.

WASTE HEAT BOILER

1 PIECE – 100 METRIC TONS
15.15 M X 4.3 M X 3.38 METERS

Cargo moved from Berlin to Point Lisas. The boiler was too heavy to cross bridges and could not be moved by road from Berlin. It was moved by barge through the rivers to Antwerp and there it was loaded onto the vessel and shipped to Point Lisas.

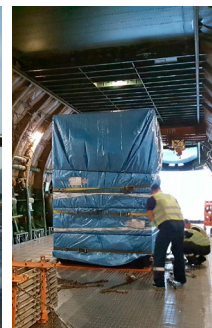
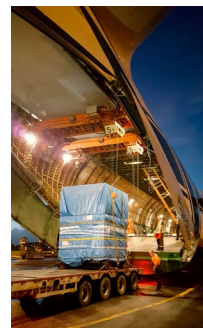
